I. BACKGROUND

The State of Maryland, Department of Public Safety and Correctional Services (DPSCS) through the Department of General Services (DGS) seeks to execute the second of five unilateral renewal options available in the Payphone Equipment and Services for Incarcerated Persons contract (Renewal). This contract was procured using an Intergovernmental Cooperative Purchasing Agreement (ICPA) through Prince William County, Virginia's PWMRADC Inmate Telephone System contract (PWMRADC Inmate Telephone System contract is available to other public bodies, public agencies, or institutions of the United States. Under the PWMRADC Inmate Telephone System contract, the Prince William County Government acts only as the "Contracting Agent" for these public bodies and Global Tel*Link Corporation (GTL) is permitted to deal directly with public bodies utilizing the contract. It was awarded by a public competitive procurement process compliant to Maryland State Procurement Statues.

Under the Renewal, Global Tel*Link Corporation would provide DPSCS with telecommunication services for incarcerated persons. Telecommunication services include local and long distance calls, debit/prepaid and collect telephone services, as well as other services, like electronic mailing, video conferences, and tablets.

II. BASIS FOR SELECTION

DPSCS reviewed telecommunication contracts for incarcerated persons throughout the country and determined the contract established by the Prince William County Procurement Office in Virginia provided the most comprehensive telecommunication services at a cost benefit to the State. GTL has provided telecommunication services for DPSCS through the ICPA with Prince William County Procurement Office since 2019, and the continuance of this ICPA with Prince William County will be advantageous to the State.

III. PRICING JUSTIFICATION

A comparison of phone call costs per minute for incarcerated persons throughout the East Coast and shows Maryland has the second cheapest calls per minute rate in the East Coast (Table 1). In addition, DPSCS negotiated a flat rate for each service provided and GTL cannot ask for additional charges.

Table 1 below provides a cost comparison of how costs for calls for both incarcerated persons and their friends and families compare to states within the East Coast.
