Background:

The State of Maryland, Department of Budget and Management ("DBM") through the Department of General Services ("DGS") seeks to execute a participating addendum ("Participating Addendum") with Accenture, LLP under the University of Virginia's Strategic Support Services Contract, #UVA-AGR-SVC-00263-Accenture, to provide priority identification and research, risk management and scenario planning, and program management support services. This Contract is available to State agencies nationwide, institutions of higher education, cities, and counties. It has been awarded through a competitive public procurement process that is compliant with Maryland statutes.

Scope Description

Under the Participating Addendum Accenture, LLP has provided a comprehensive proposal that will provide an independent, structured, and research-based approach to assist the State with the following:

• Priority Identification and Research. The contractor will research the president-elect's party platform and campaign policy proposals; supportive third-party organization policy recommendations; legislative agenda from the incoming majority party in the U.S. House of Representatives and the U.S. Senate; and transition committee announcements and position and organize them against impacted state priorities, goals, and programs. A key outcome of this work will be to understand the potential impact of changes to federal policies, funding, and programs on the Moore administration's priorities, and identifying potential Executive Branch appointees in key agencies and Congressional staff on relevant committees.

- Risk Management and Scenario Planning. The contractor will identify and assess risks (and/or
 opportunities) and outline mitigation plans and response activities, reviewing and building upon
 existing scenario planning work done by the Office of the Governor. A key outcome of this work
 will be prioritized areas to focus State resources and efforts and consider potential avenues for
 legal challenges.
- Program Management Support for the Administration. The contractor will perform project
 management activities for Administration officials and scenario planning working groups charged
 with planning for this transition. This support may include meeting support and tracking of action
 items.

The resulting services from this ICPA would allow the State to look for the potential impact of changes to federal policies, funding, and programs on the Moore administration's priorities and identify potential Executive Branch appointees in key agencies and Congressional staff on relevant committees. The Federal Transition Strategic Advisory Support Services project will identify and implement initiatives to improve the operational efficiency of Maryland's mission-support functions and large programs, focusing on cost savings and performance improvement.

Basis for Selection:

The use of this procurement method will reduce the time period between need determination and delivery of the solution, will ensure expeditious transparency to the citizens of Maryland. In accordance with COMAR 21.05.09.04(B)(1)(b), it is determined that this Participating Addendum promotes administrative efficiencies, and promotes intergovernmental cooperation. The Intergovernmental Cooperative Agreement is in the best interest of the State and is not intended to evade the purposes of Division II of the State Finance and Procurement Article.
